Commitment to achieving Net Zero

KCOM group limited is a provider of broadband and copper network telephony services, as a group of companies we are committed to achieving Net Zero emissions by 2040 with an interim target to reduce our Scope 1&2 emissions by 92.5% by 2030.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

The figures below are the restated figures for 2020/21 following the divestment of the National Business for the KCOM Group of companies, during that reporting year we did not report on the full range of scope 3 emissions

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

To be Net Zero by 2040.

We project a Scope 1 & 2 (location based) 92.5% reduction by 2030 (equivalent to 4217 tCO $_2$ e by 2030)



Carbon Reduction Projects

KCOM Group Limited is committed to reducing its carbon emissions and had already carried out a number of initiatives to achieve this including:

- Purchase of renewable energy via Renewable Energy Guarantee of Origin Certification
- Installation of solar panels at one of our main offices, which generate 18% of the site's consumed electricity
- Introducing a small fleet of electric vehicles

Going forwards we have plans to reduce our emissions further as we decommission the current copper telephone network and move customers onto the fibre network, this will yield an estimated 35% reduction in our current electricity consumption and an estimated 25% reduction in our CO2e emissions.


Other initiatives include, phasing out diesel and petrol fleet vehicles and replacing with electric or hybrid vehicles, increasing the efficiency of our building stock and installation of solar panels.

The graph and table below show our plan and the anticipated CO2e reductions.

We are currently assessing our scope 3 emissions and will be building these into our overall carbon reduction plan.
