

Ethernet Connect Access Service

KCOM has agreed to supply the Ethernet Connect Access Service to the CP within the Hull Area. In the event that the CP wishes to connect to a CP Site or End User Site located outside of the Hull Area, KCOM will provide the Ethernet Connect Access Service to a CP Site located within the Hull Area and the CP will be responsible for sourcing and connecting any capacity for connection from the CP Site to a site outside of the Hull Area. The CP may utilise equipment owned by a Third Party CP at the CP Site, subject to a separate agreement with the third party involved.

The CP can only use the Ethernet Connect Access Service to connect:

- (a) CP Site or Exchange Site to CP Site
- (b) CP Site or Exchange Site to End User Site

The Ethernet Connect Access Service cannot be used for connections which are outside the scope of those identified above, including:

- (a) where the usage is for the purpose of building or extending core network; or
- (b) where the intent is to replicate core network.

Note that, except for the connectivity allowed under this Agreement, the Ethernet Connect Access Service must not be used for directly cabled NTE to NTE connection with any other KCOM provided service. KCOM will not be liable for any incidents, reduction in service performance or service failures which result from the Ethernet Connect Access Service being connected in a directly cabled NTE to NTE configuration or if Ethernet Connect Access Service is connected within the CP Site in a NTE to NTE configuration.

Excess Construction Charges (ECCs)

KCOM leased line pricing incorporates standard connection charges for single circuits, dependent upon whether there is existing fibre installed or fibre needs to be installed at the site. Wherever there is fibre installed at the site, this will be utilised and no further charges will be raised. Standard charges apply for new installations where fibre must be installed at the site and this is readily provisioned from nearby network. When an order is taken additional charges may be applied in various instances including the following:

- (a) Resilience is requested, dependent upon the level of separacy required;
- (b) Client site is a significant distance from established KCOM network;
- (c) Exceptional costs are identified e.g. a new crossing of a railway line.

KCOM will absorb the first £2,800 of ECCs. Note that exemptions will NOT apply where:

- (a) Time Related Charges are incurred for out of hours working
- (b) Circuits are alternatively routed at the CP / End User's request
- (c) An exemption has already been given at the site on an earlier occasion

Costs will be charged as an ECC where they exceed the exemption threshold of £2800. The ECC is in addition to the published connection fee. In all instances rentals will continue to be at standard published rates for each circuit type, regardless of whether ECCs have been incurred in construction.

Connection Charges

Connection charges are all per circuit.
