SCHEDULE 113 Operator Free Phone Service Calls

1. Definitions

1.1 In this Schedule 113, a reference to a paragraph or Appendix unless stated otherwise, is to a paragraph or Appendix of this Schedule 113. Words and expressions have the meaning given in Clause 1, except as shown below:

"Operator Free Phone Call"	a Call made by a Calling Party dialling an Operator Free Phone Service Provider's number within the Number Range specified in Appendix 113.1, which sets up the Call to the Operator Free Phone Service Provider, and which if such a Call were made by an Operator Customer on the Operator System would be free of charge and paid for by the Operator Free Phone Service Provider;
"Operator Free Phone Service Provider"	a person who has contracted with the Operator for delivery of Calls using telephone numbers within the Number Range specified in Appendix 113.1 The

a person who has contracted with the Operator for delivery of Calls using telephone numbers within the Number Range specified in Appendix 113.1 The expression shall also include the Operator in respect of such telephone numbers if the Operator has published those numbers as being available to call the Operator itself in respect of certain Operator services.

2. Description of Service

- 2.1 Subject to the provisions of this Schedule 113, the Operator shall convey Operator Free Phone Calls handed over from the KCH System to the appropriate terminal apparatus nominated by the Operator Free Phone Service Provider or by the Operator if the terminal apparatus is connected to the Operator System, or to the KCH System or a Third Party Operator's system if the terminal apparatus is connected to that System or Third Party Operator's system.
- 2.2 Operator Free Phone Calls shall be included in the Traffic Forecast in accordance with Annex 3.
- 2.3 The parties shall agree in advance all necessary technical requirements, including Call set-up and cleardown sequences, for the conveyance of Calls pursuant to this Schedule 113.

- 2.4 KCH shall ensure that its promotional material will not undermine the public perception that Operator Free Phone Calls are free to Operator Customers.
- 2.5 The Operator shall convey Operator Free Phone Calls during those periods of time and at the same standard and quality of service as the Operator conveys similar Calls.
- 2.6 Each party shall correct faults which occur in its System which affect the conveyance of Operator Free Phone Calls in accordance with such party's normal engineering practices. For the avoidance of doubt, neither party warrants that its System is, or will be, free from faults.
- 2.7 If there are abnormally high volumes of Operator Free Phone Calls that the Operator System cannot convey, KCH may apply network management controls in the KCH System or the Operator may apply network management controls in the Operator System.
- 2.8 International Calls and Indirect Access Calls are not conveyed pursuant to this Schedule 113.

3. Routing

- 3.1 The conveyance of Operator Free Phone Calls shall be in accordance with the routing principles specified in Annex 2.
- 3.2 Operator Free Phone Calls handed over to the Operator by KCH shall be handed over at an Operator Switch Connection which is as near as reasonably practicable to the geographical location from which the Call was initially made or as otherwise may be agreed in writing by the parties.

4. Charging

- 4.1 For the conveyance of each Operator Free Phone Call by KCH, the Operator shall pay KCH a charge calculated in accordance with the rate for such a Call specified from time to time in the Kingston Interconnection Price list.
- 4.2 If an Operator Free Phone Call is made from a KCH Public Call Box or a KCH Temporary Call Box (each as defined in Schedule 1 Part 1 of the KCH Licence), the Operator shall in addition to any other charges pay KCH for each such Call, the KCH Payphone Access Levy specified from time to time in the Kingston Interconnection Price list.

5. Commencement Date

5.1 The Operator shall convey Operator Free Phone Calls handed over from the KCH System commencing on a date to be agreed in writing by the parties.
