SCHEDULE 117

Operator Personal Numbering Service (PNS) Calls

1. **Definitions**

1.1 In this Schedule 117, a reference to a paragraph or Appendix unless stated otherwise, is to a paragraph or Appendix of this Schedule. Words and expressions have the meaning given in Clause 1, except as shown below:

"Call Completion Service" a service whereby a Calling party may

record a message for later access by

the Operator Customer;

"Operator PNS" a personal numbering service whereby

> a Calling party dials a telephone number allocated to an Operator Customer prefixed with the codes specified in Appendix 117.1 in order to access a network facility which either

a Call via the Operator PNS.

redirects the Call to a particular telephone number or to a Call Completion Service, as directed from time to time by the Operator Customer;

2. **Description of Service**

"Operator PNS Call"

- 2.1 Subject to the provisions of this Schedule 117, the Operator shall deliver Calls handed over to the Operator System from the KCH System prefixed with the codes specified in Appendix 117.1, to the Operator PNS.
- 2.2 Subject to the provisions of this Schedule, the Operator shall convey Operator PNS Calls handed over from the KCH System to the appropriate terminal apparatus nominated by the Called party where the terminal apparatus is connected to the Operator System, or to the KCH System or a Third Party Operator's system where the terminal apparatus is connected to that System or system.
- 2.3 Operator PNS Calls shall be included in the Traffic Forecast in accordance with Annex 3.
- 2.4 The parties shall agree in advance all necessary technical requirements, including Call set-up and clear down sequences, for the conveyance of Calls pursuant to this Schedule 117.

- 2.5 The Operator shall convey Operator PNS Calls handed over from the Operator System during those periods of time and at the same standard and quality of service as the Operator conveys similar Calls.
- 2.6 Each party shall correct faults which occur in its System which affect the conveyance of Operator PNS Calls in accordance with such party's normal engineering practices. For the avoidance of doubt, neither party warrants that its System is, or will be, free from faults.
- 2.7 If the Operator PNS Call is redirected to a Call Completion Service, the Operator shall procure that the Operator System shall immediately return to the KCH System an Address Complete Message immediately followed by an Answer Signal.
- 2.8 International Calls are not conveyed pursuant to this Schedule 117.

3. Routing

3.1 The conveyance of Operator PNS Calls shall be in accordance with the routing principles specified in Annex 2.

4. Charging

4.1 For the conveyance of each Operator PNS Call by the Operator, KCH shall pay the Operator a charge calculated in accordance with the rate for such a Call specified from time to time in the Kingston Interconnection Price List.

5. Commencement

5.1 The Operator shall convey Operator PNS Calls handed over from the KCH System commencing on a date to be agreed in writing by the parties.
